Dear Secretary Haaland and Director Young:

The House Committee on Natural Resources (Committee) conducts one of the most robust hearing schedules in Congress. In 2023 alone, the Committee held 92 hearings across its Full Committee and five Subcommittees. As the House of Representatives' authorizing Committee for the Department of the Interior (DOI), and as part of this Committee's ongoing oversight of DOI, the lack of timely responses to questions for the record (QFRs) following Committee hearings is deeply concerning.

The Committee is troubled by the fact that witnesses from the Biden administration have appeared before the Committee without adequate preparation to answer questions during hearings. Instead, they seem to prefer taking QFRs, either to avoid providing information to the Committee and the American people, or as a dilatory tactic to provide responses with such a significant delay that it renders the response moot. Members may also submit QFRs to delve deeper into the issues, or in the interest of time. Regardless of motivation, Members expect the responses to their questions to be treated with the same gravity and urgency as if they were asked in person, at the hearing. A recent example of this disregard were the responses to QFRs received by the Committee from Secretary Haaland's April 19, 2023, appearance before the Committee on President Biden's Fiscal Year 2024 budget request. The responses to those QFRs were only just received on January 12, 2024, nearly nine months after her testimony. The Committee clearly states in its Rules<sup>1</sup>, and at the conclusion of each hearing, as read aloud by the Chair, that under Committee Rule 3, the hearing record will be held open for ten business days for responses. It is shameful and unacceptable for DOI and the Office of Management and Budget (OMB) to take upwards of nine months to provide responses to the Committee.

The alarming disregard for the American public's right to the timely presentation of the full scope of the hearing is not acceptable. Of the 40 instances of DOI officials testifying before the Committee during the First Session of the 118<sup>th</sup> Congress, 21 sets of QFRs remain outstanding and unanswered, the oldest of which dates back to March 2023. There is no justifiable reason for the many months-long delays in receiving responses to Members' questions for the record. It can only be interpreted as an intentional obfuscation on behalf of DOI and OMB to hinder the oversight and legislative work of the Committee.
