
## 12 Town Halls in 4 Months!

This week included a big milestone in my pledge to hold a town hall in every county, every year: in less than 4 months, I have now hosted a town hall in over half of Wyoming's counties. Those of you who have followed my newsletter for a while are aware of how much has occurred in DC these past few weeks, so there was no shortage of lively conversation this past week as I traveled the state.

I talked about many of the challenging votes that we have taken in Congress, discussing in depth how I'm standing for Israel while trying to mandate accountability for taxpayer money being sent overseas, while also trying to force the government to obtain warrants before surveilling American citizens. I provided updates on bills of mine – like the one to allow Indian tribes to enter into leases for their trust lands for up to 99 years if they so choose, as well as a bill to revise how expression of interest fees work for our energy industry (which now awaits a full vote from the House of Representatives). I also discussed new legislation to help rein in bureaucratic overreach and protect our legacy industries.

These town halls also give me a chance to directly address some of the significant concerns that you have about our elections, border security, our burgeoning national debt, and how to keep our children safe. Unfortunately, there is much to be concerned about. Our nation is facing significant crises that span from the invasion of illegals across our borders, to the drugs in our communities, to boys and men in girls locker rooms. It is through this newsletter and my town halls that I am able to share how I am fighting for and defending Wyoming's values and priorities.





## Biden Admin Issues New Regulations Aimed at Erasing Women

On April 19, Biden's Department of Education released new Title IX regulations that are designed to cater more toward boys and men who masquerade as girls and women than actually doing anything for the real women that Title IX was designed to protect. Title IX was originally enacted to protect individuals from being discriminated against on the basis of sex in education programs or activities receiving federal funds. The Biden administration's radical rewriting of the law expands the definition of "sex" to now include "gender identity," a concept entirely unknown when Title IX was written. In other words, this is yet another attempt to erase biological sex.

To make matters worse, these new regulations could conflict with states' rights, as many states have enacted laws banning males from participating in girls' and women's sports and from using bathrooms intended for women and girls. Forcing women to share bathrooms, locker rooms, and play sports against men is dangerous and an affront to the rights we have worked so hard to achieve and were finally awarded through the passage of Title IX. Several states have rightfully already committed to fighting back against this destructive policy.

I have cosponsored multiple pieces of legislation that seek to safeguard women and girls in sports, including [H.R. 734](#), the Protection of Women and Girls in Sports Act, which passed the House of Representatives, and [H.R. 7187](#), the Protection of Women in Olympic and Amateur Sports Act. As your representative, I will continue to do all that I can to prevent the Biden administration from trampling on basic biological principles.

## Antisemitism on College Campuses Rages on

Anti-Israel protests on college campuses have surged nationwide, putting Jewish students' safety at risk. I urge the presidents of the universities to take swift action to protect Jewish students from increasing threats and attempts of violence. While I will always defend Americans' right to free speech, I will also always condemn those who abuse our First Amendment privileges to spew hateful anti-America and anti-Israel rhetoric such as "death to America" and "from the river to the sea." I thank the brave law enforcement officers who have swiftly stepped in to keep these protests at bay.


To that end, I have voted in favor of numerous pieces of legislation that condemn terrorist attacks on Israel and provide Israel with the funds it needs to defend itself, including the Israel security supplemental that President Biden signed into law on Wednesday. I will continue to stand with Israel and the Jewish community in their fight to defend themselves against terrorist organizations both at home and abroad.

## Biden Administration Continues its Attack on Wyoming Coal


On Thursday, Biden's Environmental Protection Agency (EPA) released a new rule which targets Wyoming coal mines and power plants in the name of so-called climate change. 




