April also brings us one month closer to Wyoming's primary elections and my communications blackout period: House rules prohibit me from sending any unsolicited communications to folks in our state for **60 days** before an election.

\$15 Million Secured for Wyoming!

Last year I asked our local and state officials to identify for my office what their community project priorities were so that I could advocate on their behalf in Congress. I am proud to announce that as a result of this coordination, nearly \$15 million of your taxpayer dollars is being returned home to Wyoming! Through Congress's community project funding request process, I submitted several infrastructure-related requests for the Fiscal Year (FY) 2024 budget and was able to secure funding for projects in 4 counties across the state to help reconstruct roads, prevent flooding, upgrade sanitation and sewage systems, and ensure Wyoming airports are able to continue operating during severe winter weather.

It's Time to Hold Alejandro Mayorkas Accountable

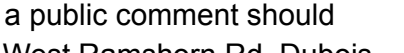
I will be joining Speaker Johnson on Wednesday, April 10th to deliver to the United States Senate the Articles of Impeachment issued against DHS Secretary Alejandro Mayorkas. On February 13, 2024, the House formally voted to impeach Mayorkas of "high crimes and misdemeanors" for his refusal to secure the border and enforce the laws passed by Congress, becoming the first ever sitting cabinet member to be impeached. Under his failed leadership, over 11 million illegals have invaded our Nation, overrunning our cities, soaking up resources that belong to American citizens, undermining national security, committing crimes, and sowing mayhem. They have flooded our communities with the deadly drug Fentanyl, killing hundreds of thousands of our sons and daughters, husbands and wives, moms and dads. Known terrorists and thousands of heavily armed military-aged males have been spotted crossing the border. Our farmers and ranchers along the southern border have been overrun, being forced to carry guns with them everywhere they go, losing millions of dollars as the result of crops being contaminated, and fearing for their lives and those of their families as they watch this catastrophe unfold.

Our Articles of Impeachment resulted from months of investigation, including interviewing witnesses, field hearings on the Border, review of video and photographs, and researching the many ways in which Mayorkas has violated the law. The evidence against him is overwhelming, and demonstrate the severity of Mayorkas' crimes. The House has performed its constitutional duty, and now it is time for the Senate to do the same by holding a fair and unbiased trial. If Senate Majority Leader Schumer decides to elevate the good of the nation above partisan politics, I will spend the latter half of this week, and potentially many more days to come, laying out the legal case against Mayorkas. If Schumer refuses to listen to the evidence and hold a trial as the Constitution requires, then justice will be denied, the humanitarian and national security catastrophe at our border will continue, and all of America will pay the price. Defending our Cyberspace Sovereignty

I'm proud to have cosponsored [H.R. 6189](#), the *Defend Our Networks Act*. This bill claws back over \$3 billion in unspent COVID funding and redirects that money towards the federal Rip and Replace program which is used in Wyoming to remove old, unreliable Chinese-produced telecommunications and install modern technology that is safe, secure, and reliable. Doing so will not only protect our networks from being weaponized by China but will help prevent blackouts and increase network resiliency throughout the state of Wyoming, all at minimal cost to the American taxpayer.

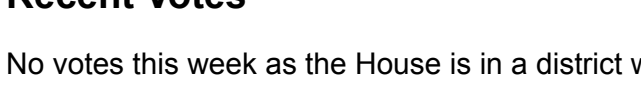

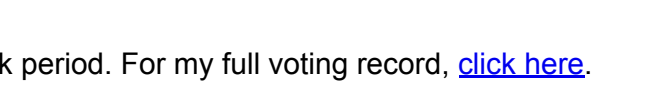

Here are some highlights of [bills I'm cosponsoring](#):

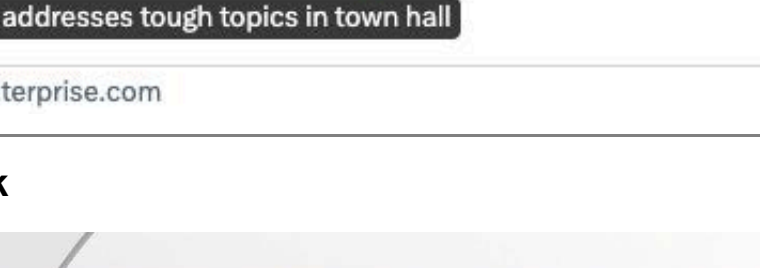
- [H.R. 700](#), the *Supply Chain Disruptions Relief Act*, which modifies liquidations of new motor vehicle inventories, among other adjustments for car dealer inventory calculations.
- [H.R. 3638](#), the *Protecting Federal Funds from Human Trafficking and Smuggling Act*, which prevents non-profits from receiving federal funds if they have violated or not certified compliance with federal laws on human trafficking, smuggling, fraud, bribery, or gratuity.
- [H.R. 6189](#), the *Defend Our Networks Act*, which repurposes unobligated COVID funds to replace unreliable and vulnerable Chinese telecommunications equipment across the nation.
