In news from DC, thank you to everyone who attended last week's Wyoming Wednesday. It was "Public Lands Week" on the floor of the House of Representatives, and we passed several bills that are especially important for energy independence and security. I also had the chance to question Interior Secretary Deb Haaland (whose primary hallmark in office is to have almost no idea of what is happening in the Department), as well as two former Biden White House officials directly involved in the censorship of Americans online during the COVID-19 pandemic. ## Interior Department Should be Held Accountable for the Havoc it Wrought on U.S. Communities

Interior Secretary [Deb Haaland appeared before the Natural Resources Committee](#) for a budget hearing. As Chair of the Subcommittee on Indian and Insular Affairs, I questioned the Secretary on what she has done for tribal communities being devastated by the Mexican cartels who have invaded our Reservations, this situation being yet one more devastating side effect of the Biden border crisis. It was just four weeks ago that [several tribal leaders testified](#) before the Natural Resource Committee's Subcommittee on Oversight and Investigations, describing the impact that the cartels' human trafficking and drug smuggling operations are having on Reservations in the west. Despite the fact that the Bureau of Indian Affairs (BIA) is within the Department of Interior, and directly under Ms. Haaland's supervision and oversight, she admitted that she has done *absolutely nothing* to deal with this scourge and has so far refused to try to convince either President Biden or Secretary Mayorkas that they *must do something* to control the border and protect our tribal members. She has never spoken with either President Biden or Secretary Mayorkas about the impact their open border policies are having on tribal communities, claiming that it is not really within her jurisdiction to do so – a convenient but worn-out excuse.

While this Administration has chosen to be willfully ignorant on these issues, the House Republicans have not only exposed how the cartels are targeting our tribes, but we are also working to pass the *Parity for Tribal Law Enforcement Act*, which provides much needed support for our over-burdened tribal law enforcement officers. I am a proud cosponsor of this bill. We have also passed H.R. 2, the strongest border security bill that Congress has ever drafted.

Shifting to Wyoming priorities, I then asked Secretary Haaland if she was aware of the Rock Springs RMP. Her answer? [She is not](#). This is one of the most consequential land management decisions currently being addressed by *her* Department of Interior (through the Bureau of Land Management (BLM)), yet she is unaware of it. Nothing more clearly exemplifies the reality of our nation being run by unelected bureaucrats pushing dangerous policy while our appointed and elected officials simply provide them cover. I will continue to fight this disastrous Rock Springs RMP.

## Recapping Public Lands Week in the House of Representatives

This week was "Public Lands Week" in the House. We voted on and passed bills that will delist the gray wolf in the lower 48 states, block the BLM's misguided and illegal "Conservation and Landscape Health Rule," defend and protect our sportsmen and women, and promote mineral development. I was proud to cosponsor and [speak](#) in debate on the *Trust the Science Act* which overrules an activist judge by delisting the fully recovered gray wolf, an Endangered Species Act success story. I was also proud to [support](#) my friend Rep. Stauber on the Superior National Forest Restoration Act which blocks the Biden Administration's withdrawal of over 200,000 acres of copper and nickel mining in Minnesota. Together, these bills will end the weaponization of our land and wildlife management laws and instead promote multiple use and conservation, so America can access, conserve, and benefit from our most cherished resources.




## The Fiscal Year 2025 Government Funding Cycle Begins

After a frustrating FY24 funding cycle, the House has officially begun its FY25 cycle by opening the process where non-Appropriations Committee members can submit their priorities for this year's bills. Here are just a few of the priorities I submitted on Wyoming's behalf:

- Defunding the Animal and Plant Health Inspection Service (APHIS) electronic identification (EID) ear tag mandate for cattle and bison.
- Defunding the Rock Springs RMP as it is currently written (i.e., Alternative B).
- Delisting the GYE population of grizzly bears.
- Blocking the USPS from consolidating and downsizing Processing and Distribution Centers, which it is trying to do in Casper and Cheyenne
- Maintaining long-standing pro-life riders which prevent taxpayer dollars from funding abortions.

My office also received double the number of requests for Community Funding Projects as compared to last year. I am proud to return YOUR tax dollars to Wyoming for the hard infrastructure needs in our communities. I will be providing more information about these specific projects as we move through the process for allocating financial resources.

Here are some highlights of [bills I'm cosponsoring](#):


- [H.R. 8218](#), the *Demanding Citizenship in D.C. Elections Act*, which requires anyone who votes in a municipal election in the District of Columbia to be a U.S. Citizen and to provide proof of citizenship.
- [H.R. 8147](#), the *Repealing Big Brother Overreach Act*, which would repeal the Corporate Transparency Act.
- [H.R. 1170](#), which prohibits Members of the House of Representatives from bringing or displaying a flag of a foreign nation on the floor of the House.
