Hello Laura,

The 119th Congress spent our second full week of session passing critical legislation protecting women both from men infiltrating their sports and illegal aliens who have committed serious crimes. Additionally, my Anti-Woke Caucus brought forth its first action item this Congress, I joined an amicus brief opposing the burdensome Corporate Transparency Act, and I introduced two pieces of legislation aimed at regulatory reform.

This coming week, I look forward to welcoming Donald Trump and JD Vance to our nation's capital to be sworn in as our next President and Vice President. The American people gave them a clear mandate in their decisive victory on November 5th, and I am excited to see it fulfilled.

## House Passes Bill to Protect Women's Sports

On Tuesday, the House of Representatives passed [H.R.28](#), the Protection of Women and Girls in Sports Act. This legislation, which I proudly cosponsored, would prevent males from competing in female sports in any athletic program or activity that receives federal funding.

The Biden administration's efforts to fundamentally rewrite the very meaning and purpose of Title IX threatens the integrity and safety of women's sports nationwide by allowing men and boys to compete against women and girls. These actions have undermined decades of progress and robbed female athletes of fair competition and opportunity. As a former high school athlete and livestock judge who was one of the first to enjoy the protections of Title IX, I am committed to ensuring fairness in female athletics. H.R.28 is a step in the right direction as it establishes commonsense definitions for sports eligibility and denies federal funding to any organizations that violate these standards. I gladly spoke in favor of this bill on the House floor—[click here](#) to watch my remarks.

## Anti-Woke Caucus Presents First Action Item

As many of you know by now, I recently became chair of the House Anti-Woke Caucus for the 119th Congress, taking over from Senator Jim Banks. Our main objective will be to work with President-elect Trump and the Department of Government Efficiency (DOGE) to rein in our bloated federal government and root out its radical and unconstitutional "diversity, equity, and inclusion" (DEI) agenda.

With that being said, I could think of no better first action item for our caucus to take than to send a letter to President-elect Trump highlighting and enumerating the legion of the Biden administration's executive orders that were designed to permeate every agency with a woke DEI ideology using billions of taxpayer dollars. The letter encourages President-elect Trump to eliminate these federal programs, grants, and offices so that we may dismantle DEI once and for all and finally place America and all Americans first. ## Continuing My Fight to Block the Corporate Transparency Act

I am continuing my work to prevent the vague and destructive Corporate Transparency Act (CTA) from going into effect, as its beneficial ownership reporting requirements would burden small businesses across the country. I have fought enforcement of the CTA in a variety of ways, including cosponsoring [H.R.425](#), the Repealing Big Brother Overreach Act, which would overturn the CTA in its entirety. I also supported legislation in the 118th Congress, which passed the House of Representatives, that would have delayed the law's implementation; the Senate, however, did not take that up.


As you may know, litigation concerning the CTA is ongoing before the courts. The Fifth Circuit Court of Appeals last month initially revived enforcement before later reversing its own decision, meaning that the federal government is now once again temporarily prohibited from implementing the CTA's reporting requirements pending a final decision. The Biden administration made an emergency appeal to the Supreme Court to reinstate its enforcement, and this week I joined an [amicus brief](#) urging the Supreme Court to deny this petition and keep the injunction in place. I remain fundamentally opposed to this law and will keep doing all I can to block it.

## Pushing for Regulatory Reform Through Legislation

I am proud to inform you that, last week, I introduced two pieces of legislation to prioritize regulatory reform. [H.R.432](#), the Seventh Amendment Restoration Act, is designed to secure Americans' right to a jury trial as protection against federal agency use of administrative law courts (ALCs). Last year, the Supreme Court ruled that the Securities and Exchange Commission's (SEC) use of ALCs violated a defendant's right to a jury trial, and my bill would further solidify this decision by requiring its government-wide applicability in response to the Biden administration's arguments otherwise.

[H.R.510](#), the Regulatory Cooling Off Act, would amend the Administrative Procedure Act to slow the onslaught of burdensome federal regulations and protect small businesses from overbearing government mandates. By slowing down the rulemaking timeline, increasing transparency, and streamlining judicial relief, this bill aims to empower the American people rather than unelected officials. As your representative, I will always push for policies that rein in the bureaucracy and place the American people first.

### Comment Alert: FWS Again Denies Wyoming's Petition to Delist the Grizzly Bear

Last week, the Fish and Wildlife Service (FWS) again denied Wyoming's petition to delist the Greater Yellowstone Ecosystem (GYE) grizzly bear and instead proposed a new management system that punishes Wyoming for its conservation success. FWS announced it was taking three separate but related actions:

1. Denying Montana and Wyoming's petitions to [delist the Greater Yellowstone \(GYE\)](#) and Northern Continental Divide Ecosystems (NCDE).
2. Proposing to create one Distinct Population Segment (DPS) that encompasses all six recovery zones, including the GYE and NCDE.
3. [Proposing to update the 4\(d\) rule for grizzly bears](#) to give limited authorities to the State and private landowners to manage bears.

The proposed rule was published in the Federal Register on Wednesday, which triggers a 60-day comment period that ends on March 17, 2025. Additionally, FWS will conduct four public hearings on the proposed rule, three in-person and one virtually. The third meeting of the installment will be virtual on January 28th, and the fourth meeting will be in person in Cody, Wyoming, at the Holiday Inn (1701 Sheridan Ave) on February 10th. While I have every intention of continuing my work to delist the bear through my legislation, the Grizzly Bear State Management Act, and by engaging with the incoming administration, I encourage you to participate in this rulemaking and make Wyoming's voice known.


### Identity Theft Awareness Week Coming Soon


During the week, the Federal Trade Commission (FTC) and partners will host free webinars and share related resources. Here are some ways you can participate in Identity Theft Awareness Week:


## Recent Photos
