I am thrilled to announce that I have fulfilled my promise to hold a town hall in every Wyoming county, every year, for the second year in a row. I kicked off my first town hall of the year in Laramie County and last week held my 23rd and final town hall in the county in which I was raised, Goshen

County. I greatly appreciate all who attended to share your thoughts on issues that matter to you and provide me the opportunity to inform you of the work I am doing as your lone representative in Washington, D.C.

While each town hall's attendees had concerns specific to their communities, common themes across all counties included the invasion at our border that has allowed nearly 12 million illegals to enter our country, runaway inflation and the bad economy created by Biden-Harris policies, and government bureaucrats trying to end our western way of life – the Buffalo and Rock Springs RMPs, EID eartags for cattle and bison, punitive energy rules designed to eliminate coal and oil, and the failure to delist the GYE Grizzly. I am honored to serve as your congresswoman and will continue to fight for policies that truly put Wyoming and America first.

Biden-Harris Weaponization Pt. 1: CIGIE I have kept you updated in recent weeks on my efforts to protect the integrity of the Inspectors General (IG) community from Biden-Harris' weaponization of the Council of the Inspectors General on Integrity and Efficiency (CIGIE), as well as its Integrity Committee (IC). Established by Congress as the "watchdog of the watchdogs," CIGIE is intended to promote best practices within IG offices and stop corruption and illegal conduct. Because the IC has the authority to investigate and

recommend the firing of an IG, the Biden-Harris administration has been using it to fire any IGs who

expose their mismanagement, corruption, failures, violations of the law, and bad policies. Joseph Cuffari, the IG for the Department of Homeland Security (led by none other than Alejandro

Mayorkas), is their latest target. It is Mr. Cuffari who has now exposed the full scope of the border crisis caused by this administration's bad policies and violations of the law, the failures of the Secret Service on January 6, 2021, the fact that DHS and HHS (Health and Human Services) have "lost" over 300,000 "unaccompanied children" who have crossed the border illegally, and other colossal failures. If there is anything that we know about the Biden-Harris regime, it is that they will spend exponentially more time and effort to cover up their failures than they spend actually trying to fix them.

The Biden-Harris administration has been trying to find a way to stop Mr. Cuffari from exposing the scope of the border crisis while also preventing the release of the damaging report on the Secret Service's actions on January 6th. There has thus been an ongoing attempt to fire Cuffari before the truth can be exposed. I, along with other members of Congress such as Reps. Andy Biggs and Thomas Massie, have been working to expose the abuses inside the CIGIE system and protect IGs like Cuffari along the way. To date, and as a result of our oversight, Mr. Cuffari remains the IG over DHS, he has been able to issue additional reports on DHS's failures, and at last, the long-expected January 6th report has been released. We consider this state of affairs a huge success as Secretary

community, especially in light of the fact that Mr. Cuffari is currently investigating the Secret Service failures surrounding the attempted assassination of Donald Trump. We have been asking one simple question: Why has Secretary Mayorkas tried to block the release of the report outlining Secret Service failures on January 6th? This report has been sitting on his desk for months and exposes what happened on January 6th while also identifying the various corrective steps that must be taken to prevent such an event from occurring in the future. Interestingly enough, had DHS and USSS followed Mr. Cuffari's recommendations, they would have

For example, the IG found: Secret Service interfered with the IG's investigation, even considering a move to block the investigation entirely. The Biden-Harris administration deleted Secret Service text messages from January 6th to protect leadership.

Secret Service faced significant communication challenges, specifically in communicating with local law enforcement, a very similar failure to what happened in Butler, Pennsylvania,

on July 13th that allowed Thomas Crooks to get in position to shoot at Donald Trump.
