Hello Laura,

As Congress returned to session last week, one of our biggest priorities was alleviating the regulatory burden on small businesses. First, I introduced legislation to protect small businesses from overbearing government mandates. I was also glad to see that a federal court blocked enforcement of the overly burdensome Corporate Transparency Act. Finally, I am proud to say that the House of Representatives passed the PROVE IT Act, which would require greater transparency for federal regulatory decisions that impact small businesses.

My Bill Would Ease Burdens on Small Businesses

On Tuesday, I introduced [H.R.10275](#), the Regulatory Cooling Off Act, which makes structural reforms to the outdated Administrative Procedure Act (APA) for the relief of all Americans, especially small businesses. This legislation is designed to slow the onslaught of burdensome federal regulations and protect small businesses from overbearing government mandates.

Passed in 1947 with hardly any substantive amendment, the APA does little to constrain the administrative state from hastily imposing burdensome regulations on Americans. To combat this, my bill requires federal agencies to wait a half year before they can enforce new rules, mandates greater transparency in relation to the public comment period, and ensures that Americans are able to bring lawsuits in their own states rather than being forced to file in activist courts that are notorious for shielding bureaucrats and rubber stamping government expansion.

Taking a page straight out of the Obama playbook, the Biden-Harris administration has spent the last 4 years weaponizing the outdated APA to dramatically expand the administrative state while crushing small businesses and essentially every legacy industry that is important to Wyoming. The Biden-Harris administration's executive branch free-for-all has imposed over \$2 trillion in annual regulatory costs, which amounts to almost \$16,000 per household. The result? Higher housing, food and energy costs, runaway inflation, and people having to choose between putting gas in their cars or food on their tables. This hidden tax paid for by the American people and businesses stifles innovation and damages national security.

The Regulatory Cooling Off Act introduces critical reforms to slow the regulatory process, enhance regulatory transparency, and establish a fairer review system. It ensures that businesses—especially small ones—have the time and tools they need to comply with or challenge rules that threaten their livelihoods.

A Win for Small Businesses!

On Tuesday, the U.S. District Court for the Eastern District of Texas delivered a huge win for small businesses by issuing a preliminary nationwide injunction to delay the implementation of the Corporate Transparency Act (CTA). This decision temporarily halts the federal government's attempt to force small businesses to meet certain burdensome reporting requirements that threaten their privacy and financial stability. While this ruling is a critical victory, the CTA remains a looming threat, and I will continue to fight for its full repeal.

I am fighting to block the CTA and working tirelessly to protect small businesses. My efforts thus far have included my vote in favor of [H.R.5119](#), the Protect Small Business and Prevent Illicit Financial Activity Act, which almost unanimously passed the House of Representatives. This bill would extend the timeline for small businesses to comply with the CTA's overly burdensome regulations. Unfortunately, the Senate has yet to take up this important legislation.

Next, I joined Rep. Warren Davidson in introducing [H.R.8147](#), the Repealing Big Brother Overreach Act, which would repeal the CTA. I am working with Rep. Davidson to encourage the Financial Services Committee to hold a markup on the bill as quickly as possible.

Finally, I joined a [letter](#) to the Department of the Treasury's Financial Crimes Enforcement Network requesting a delay in the implementation of CTA enforcement to ensure small businesses are not unfairly penalized. I will continue to do all I can to cut red tape and defend Wyoming's small business owners.

PROVE IT Act Passes House of Representatives

On Thursday, the House of Representatives passed [H.R.7198](#), the PROVE IT Act of 2024, which I cosponsored and spoke in favor of both in the Rules Committee and on the House floor. Current law requires agencies to assess the impact of their regulation on small businesses. Today, agencies either fail to estimate or underestimate the impact of regulation on small businesses in 75% of rulemakings. The PROVE IT Act seeks to address this serious concern by allowing small businesses to petition for an agency determination if a business believes the proposed rule would have a more significant economic impact than the agency claims.

All too often, agencies ignore or severely underestimate the negative impact their rules will have on small businesses, and on average, these agencies miss the direct cost by a whopping 40%. That figure does not even consider the indirect costs that Americans must absorb in complying with these new agency rules. I am proud this bill passed the House, and I look forward to its consideration in the Senate.
