Last week was full of interesting developments in Washington, D.C., with the exposure of the Democrats' and the mainstream press's efforts to cover up Biden's severe cognitive decline (and utter incompetency), and the Supreme Court's release of several important decisions. ## Exposing the Lies Spread by our Government During COVID

On Wednesday, I participated in a Judiciary Subcommittee hearing focused on exposing the administrative state's failed response to COVID-19. This hearing came as the [Committee released a report](#) based on interviews with former FDA employees about how Biden administration officials and bureaucratic leadership pressured FDA employees to cut corners and compromise safety testing to rush out an experimental Covid vaccine, all so they could use this fake "full licensure" to justify vaccine mandates. Several FDA experts who raised concerns about early vaccine injuries such as myocarditis were removed from their positions and censored so nothing could stand in the way of Biden's effort to force vaccines on the entire nation, young and old, sick and healthy. Biden and Fauci then used the misinformation that they created (or paid to be created) to impose draconian mandates and diktats, harming all aspects of our country, from our schools and school children, to small businesses (many of whom never recovered). They also severely undermined our trust in the healthcare industry, caused untold suffering for those harmed by the vaccines, and isolated senior citizens from their families during their time of critical need.

I am proud that one of the first pieces of legislation I cosponsored as your representative was [H.J.Res.7](#), which terminated the COVID national emergency and was signed into law. I also voted to end the COVID Public Health Emergency and to require the intelligence community to disclose everything it knows about the virus's outbreak in Communist China. ## Biden's Border Crisis – Keeps Getting Worse

The Inspector General (IG) of the Department of Homeland Security (DHS) continues to find that the Biden border crisis is even worse than we previously understood. The latest report highlights how the State Department and Customs and Border Patrol are failing to properly screen nonimmigrant visa holders coming into the country. Over the last four years, this failure has allowed at least 7 million individuals to enter our country without proper screening. Every day seems to provide a new revelation about how bad this border crisis is and the abject failure of the Biden administration to not only stem the flow, but its affirmative efforts to drag as many illegals across that border as is humanly possible. This news about the violation and abuse of the visa screening process is just the latest example of the bad faith and corruption of this administration.

The IG, in exposing the Biden administration's violation of visa screening protocols, is simply doing his job as mandated by the law. The Biden administration, however, is seeking to silence him for reporting on the border crisis it intentionally created. The administration is doing so by weaponizing a shadowy entity known as the Integrity Committee (IC) of the "Council of the Inspectors General on Integrity and Efficiency." It is through the IC that the Biden administration is attempting to force out any IG who seeks to expose its bad acts, failed policies, and violations of existing law. I recently joined Rep. Andy Biggs (R-AZ) and seven other Republican members of Congress to send a letter to the IC demanding answers on its decision to not investigate alleged criminal activity and abuse by employees in the DHS IG's office at the same time it was attacking an IG for simply doing his job. 
## House Passes Three Vital Appropriations Bills

On Friday, the House of Representatives passed three important appropriations bills—[H.R.8752](#), the Department of Homeland Security Appropriations Act of 2025, [H.R.8771](#), the Department of State, Foreign Operations, and Related Programs Appropriations Act of 2025, and [H.R.8774](#), the Department of Defense Appropriations Act of 2025. These bills make cuts where appropriate, adhere to budget caps imposed in law last year, prioritize border security and countering the Chinese Communist Party, and end woke policies the Biden administration has imposed by executive fiat on these agencies.

I am also happy to announce that my [amendment](#) to prohibit classified teleworking and remote working for Department of Defense (DoD) employees was agreed to and included in the final text of the DoD appropriations bill. The COVID-19 pandemic is over, and one of my top priorities this Congress is returning the federal workforce to the office and cracking down on wasted federal office space.

I also introduced two amendments to H.R. 8771 that did not pass – an [amendment](#) to block funds from the United Nations Food and Agriculture Organization and an [amendment](#) to prohibit funding for the United Nations International Organization for Migration's activities in the Western Hemisphere.
