Back in Washington, D.C., I teamed up with several of my House Republican colleagues to introduce legislation to strip the IRS of tens of millions of dollars' worth of firearms and ammunition that could be weaponized against American citizens. I also sat down with the chairman of the Congressional Western Caucus to discuss the need to modernize the Endangered Species Act and joined the Wyoming congressional delegation in issuing a response to concerns raised by lawyers and judges in our state. I have highlighted these initiatives below.

Working to Disarm the IRS

I was proud to join Reps. Barry Moore (R-AL), Mary Miller (R-IL), and Clay Higgins (R-LA) in introducing [H.R.2915](#), the Why Does the IRS Need Guns Act. This bill would strip the IRS of its firearms and ammunition and would force the agency to transfer the massive stockpile of weapons currently in its possession to the General Services Administration, who could then sell the firearms to licensed dealers and the ammunition to the general public. The bill will also transfer the agency's Criminal Investigations Division to the Department of Justice.

The Biden-Harris administration spent a whopping \$10 million on firearms and ammunition for IRS employees. This is especially troubling in light of the Select Subcommittee on the Weaponization of the Federal Government's investigation into the IRS, exposing patterns of political targeting and harassment by agents (including against independent journalist Matt Taibbi, who had agents visiting his house at the very time that he was testifying about the "Twitter Files" before our committee). The Why Does the IRS Need Guns Act will ensure the agency sticks to its mission of collecting revenue rather than moonlighting as a paramilitary law enforcement agency susceptible to politicization.
