down (3.2% inflation) as compared to the level they reached a year ago (9.1%), but they conveniently neglect to admit that inflation was at 1.4% when Biden took office - 18 months before inflation reached the highest level in over 40 years; by contrast, inflation never exceeded 2.4% under President Trump. Here are some more numbers on how "Bidenomics" is actually performing: Under Biden, gas prices now average over \$3.70 nationwide (and rising), with a previous average of \$5.03 in June 2022. Under Trump, the highest average gas price was \$2.99. Groceries now cost an American family \$709 more PER MONTH than what they cost just 2 years ago. Mortgage rates on homes have reached 7.09% this week – 21-year high – despite being at a 20-year low when Biden took office. • For 20 of the last 22 months, wage growth has been below the inflation rate. The budget deficit has exceeded \$2 trillion in the last 12 months, and the national debt is now expected to be \$8 TRILLION higher than the forecast when Trump left office. The federal interest rate is at its highest level since 2007.

Perhaps a better way to look at inflation is not by comparing year-over-year rates, but the overall inflation impact since a president took office. Under this "Presidential Inflation Rate" (PIR), the Biden Administration sits at 15% – the highest since Jimmy Carter, while Trump's rate is a mere 4.1% –

Earlier this month, Rocky Mountain Power requested the Wyoming Public Service Commission to approve two electricity rate increases for the state. In a time of already high energy prices thanks to President Biden's energy poverty agenda, these elevated prices will not only increase the cost of utilities for everyday Wyomingites but threaten to drive costs for trona mining operations up by 33%.
