Hello Laura,

I was glad to be able to have a few days in Wyoming after spending several busy weeks in Washington, D.C. I hope you all had a wonderful Wyoming Statehood Day on July 10th and reflected on how blessed we are to live in the greatest state—and nation—on Earth.

Now that we have passed the One Big Beautiful Bill Act, it is time to focus on other key priorities for Wyoming. Last week, I partnered with Senators Lummis and Barrasso to introduce a bill modernizing the state's permanent school trust fund. I also joined a letter opposing National Institutes of Health (NIH)-funded animal experiments and attended the joyous celebration of the opening of the first rare earth mine in 70 years. ## Honoring Wyoming's Legacy and Investing in Our Future

On Thursday, coinciding with Wyoming Statehood Day, I joined Senators Lummis and Barrasso in introducing the Wyoming Education Trust Modernization Act. This important legislation updates Wyoming's State Act of Admission, the foundational law established by Congress in 1890 that set the terms for our statehood, including rules around taxation, public lands, and education.

Under the current law, when the state sells, exchanges, or otherwise disposes of lands originally granted by the federal government for the benefit and funding of public schools, the proceeds must be deposited into a permanent land fund. These funds cannot be spent—only the interest earned can be used to support K-12 education. While this system was designed to ensure long-term stability, it also limits the opportunity to fully realize the potential of these resources.

Wyoming's students deserve every opportunity we can provide, and that begins with strengthening the sustainability and impact of our education funding. The bill offers a commonsense, forward-looking solution. By allowing the state to use modern investment strategies, we can responsibly grow our education trust fund and better support Wyoming's schools today and for generations to come.

This legislation honors the constitutional protections that have served us for more than a century while adapting to meet the needs of tomorrow. It is about keeping our promises to our communities, to our schools, and most importantly, to Wyoming's children.


## Safeguarding Animals from NIH-Funded Experiments

I was proud to join Rep. Paul Gosar (R-AZ) and nine of my Republican colleagues in sending a letter to NIH Director Dr. Jay Bhattacharya, urging the agency to end all remaining Fauci-era experiments on dogs and cats. Despite the fact that Dr. Fauci has retired (thank goodness), many of the painful and unnecessary experiments he authorized are still ongoing, and some are even slated for funding through 2031.

The Trump administration has made significant progress in halting these inhumane practices across several federal agencies—including the Navy, the Food and Drug Administration, and the Environmental Protection Agency—but more work remains. We must ensure that innocent animals are no longer subjected to cruel tests, such as deliberately infecting healthy beagles with viruses and experimental drugs while withholding pain relief.

Despite the troubling history surrounding Fauci's experiments, I am pleased that many of these animals have found refuge at the Kindness Ranch in Hartville, Wyoming, after being rescued from various research facilities. I am grateful to John Ramer and the dedicated staff and volunteers for giving these former research animals a second chance at a better life.



### Public Comment Alert!


### Free Dental Care for Veterans
