Hello Laura,

I had another interesting week serving as your representative in Washington, D.C., and I am looking forward to returning to Wyoming. I will be traveling across the state while I am home over the next week, meeting with constituents and community leaders and holding five more town halls.

We have had several jam-packed days as we continue to move forward with our conservative agenda. The House has now passed the Rescissions Act, and I participated in two important committee proceedings—one in the Judiciary Committee and another in the Natural Resources Committee. I'll share more details on all these issues below.

House Passes Legislation to Codify DOGE Cuts

On Thursday, the House of Representatives passed H.R. 4, the Rescissions Act of 2025. Under the Impoundment Control Act of 1974, the President may request the rescission of any unobligated funds allocated by Congress within the same fiscal year. This particular package represents the Trump administration's first formal effort to eliminate billions of dollars in waste, fraud, and abuse uncovered by the Department of Government Efficiency (DOGE). President Trump's \$9.4 billion rescission request includes \$8.3 billion in cuts to the Department of State and U.S. Agency for International Development (USAID) and \$1.1 billion in cuts to the Corporation for Public Broadcasting, which funds NPR and PBS.

I've long opposed forcing American taxpayers to fund unnecessary and corrupt foreign aid—particularly programs that promote values contrary to those held by the vast majority of us, including anti-American propaganda and LGBT+ and pro-abortion initiatives. We must prioritize the safety, security, and well-being of our own citizens before sending billions of dollars abroad. We must also target our spending on programs and policies that actually further America's interests on the global stage.

I also support the Trump administration's efforts to end taxpayer subsidies to biased media outlets like NPR and PBS. NPR's CEO, Katherine Maher, has made numerous inflammatory comments on X, referring to President Trump as a "fascist" and "deranged racist" and claiming America is "addicted to White supremacy." Her testimony before the Oversight Committee further exposed how far NPR and PBS have strayed from their original missions and have become the mouthpieces for the Democratic party.

PBS has continued to air controversial programming that is opposed by most Americans, catering to a small subset of liberals rather than the country as a whole. NPR and PBS both receive substantial funding through private sector donations. Those individuals who are interested in retaining this type of programming are free to do so, but taxpayer funding should not be used. The private sector will instead fill the void, and these organizations will simply need to compete in the private marketplace as most media outlets do.

Taxpayer dollars should be spent responsibly and in ways that reflect the values of the American people. I'm pleased that the House passed this significant rescissions package—a meaningful step toward reining in government overreach and cutting wasteful spending. I look forward to its swift consideration in the Senate.

Bills to Protect Children Pass Judiciary Committee

On Tuesday, I was proud to lead the debate during the Judiciary Committee markup of H.R. 3492, the Protect Children's Innocence Act of 2025. This legislation aims to stop the irreparable harm being done to minors under the label of "gender-affirming care." It is long past time to stop these procedures—including chemical castration and irreversible surgeries—for what they truly are: the mutilation of America's children and child abuse. This bill amends existing federal criminal law that bans female genital mutilation to hold accountable those who facilitate and perform these procedures, which often result in permanent bodily harm, sterilization, and psychological damage.

One of my highest priorities in Congress is to defend those who cannot protect themselves—especially children and the unborn. Along those lines, I also supported H.R. 589, the FACE Act Repeal Act of 2025. This bill would repeal the Freedom of Access to Clinic Entrances (FACE) Act, originally intended to protect access to reproductive health facilities, crisis pregnancy centers, and places of worship.

Despite its stated purpose, the Biden administration weaponized the FACE Act to target pro-life Americans—harassing and imprisoning peaceful protesters while ignoring the wave of violence directed at pregnancy resource centers and churches, especially in the aftermath of the *Dobbs* decision. While President Trump already curtailed these abuses, we must take steps to ensure future pro-abortion administrations cannot abuse this law to target Americans for their beliefs.

I'm pleased to report that both the Protect Children's Innocence Act and the FACE Act Repeal Act passed out of the Judiciary Committee. I look forward to their full and thoughtful consideration on the House floor.

Prioritizing and Protecting Wyoming's Natural Resources

On Thursday, the Natural Resources Committee held a hearing to review President Trump's Fiscal Year 2026 budget request for the Department of the Interior (DOI). I had the opportunity to question DOI Secretary Doug Burgum on several key priorities for Wyoming.

Among the issues I raised was the long-overdue delisting of the Greater Yellowstone Ecosystem (GYE) grizzly bear. Wyoming has invested well over \$1 million and dedicated substantial resources to recovering the GYE grizzly bear. The GYE grizzly has met and exceeded all recovery goals for well over two decades—a success that we should be celebrating—yet it remains listed as "threatened" under the Endangered Species Act, primarily because of activist judges in Montana. It is time to recognize this victory for what it is, delist the grizzly, and dedicate our limited resources to those species that actually need additional protections. Mr. Burgum is committed to working with Wyoming to make sure that we finally delist this species.

I also pressed the Secretary for additional updates on the DOI's progress in reviewing and revising the Buffalo and Rock Springs Resource Management Plans, and I urged a halt to the construction of new onshore and offshore wind turbines. I want to thank Anne Brande, Executive Director of the Albany County Conservancy, for her work in helping inform members of the committee about the dangers associated with wind energy—especially the fact that wind turbines now account for 44% of all eagle deaths in Wyoming. That is simply not acceptable.

I was encouraged to hear Secretary Burgum not only acknowledge these concerns, but make a commitment to working with Wyoming to address them. I look forward to continuing this important partnership with the Trump administration to achieve true American energy independence through focusing our efforts and resources to pursuing reliable and affordable energy resources.



Recent Photos


