Hello Laura,

I was thrilled to be back in Wyoming last week, traveling the state, holding five more town halls, touring local businesses and attractions, and meeting with constituents. I greatly appreciated the opportunity to directly engage with so many of you, as I believe hearing your comments and questions is vital to serving as your representative.

Back in Washington, D.C., the U.S. Supreme Court delivered two important victories on key issues I have been fighting for in Congress. I also wanted to take a moment to provide information on an issue I have heard a great deal about from concerned Wyomingites—public lands sales. Providing Information on Proposed Public Lands Sales

I have received numerous inquiries regarding the legislative proposal from the Senate Energy and Natural Resources Committee to sell two to three million acres of select Bureau of Land Management and U.S. Forest Service lands. While this proposal is not currently under consideration in the House and has not been voted on in this chamber, I want to provide you with accurate and relevant information about what is being proposed. There is a significant amount of misinformation circulating, including inaccuracies in the map released by the Wilderness Society. Completing Additional Town Halls

One of my top priorities as your congresswoman is to fulfill my promise to hold a town hall in every Wyoming county each year. I am proud to share that I am continuing this commitment with my 15th town hall of the year, which took place on Friday in Weston County. Just last week, I also held town halls in Park, Big Horn, Campbell, and Crook Counties. I am truly grateful to everyone who attended—your questions, insights, and engagement are invaluable.

I encourage all of you to stay involved by reaching out to my offices or joining one of my many events across the state. Your input helps me better represent your interests and ensures your voices are heard in Washington, D.C. With eight more counties left on my town hall tour, I am excited to keep connecting with communities throughout Wyoming and expect to announce the remaining town halls throughout the summer.

Strengthening States' Rights and Children's Safety

I am proud to report that the U.S. Supreme Court delivered a significant victory for states' rights and the safety of our children by upholding Tennessee's ban on "gender-affirming care" for minors in the case of *U.S. v. Skrmetti*. This ruling reinforces the authority of states to make decisions that protect the health and wellbeing of their citizens. As many of you know, the state of Wyoming stood firmly in support of Tennessee's position by filing an amicus brief, affirming the importance of allowing states to determine their own policies on this sensitive issue.

I have consistently maintained that these procedures constitute child abuse, exposing minors to irreversible harm at a vulnerable stage in their lives. Protecting our children from such risks is not only a moral imperative but a critical responsibility of government. As we move forward, I remain committed to advocating for laws and policies that prioritize the safety, health, and innocence of our children, and I will continue to work alongside fellow lawmakers, states, and families to uphold these fundamental protections.

SCOTUS Delivers Win for Our Constitutional Rights

In 2017, FBI agents wrongfully raided Curtrina Martin's Atlanta home during a pre-dawn anti-gang operation, mistakenly targeting the wrong address. Fortunately, the Federal Tort Claims Act (FTCA), created in 1946 and expanded in the 1970s to cover wrongful law enforcement actions, allows Americans to seek damages in such cases.

Despite this, the Eleventh Circuit denied Martin's claim in a way that undermines the FTCA and the Constitution's Supremacy Clause. That is why, together with Senator Lummis, I led two bipartisan amicus briefs in support of Martin and the laws Congress enacted to protect the rights of all Americans. I am pleased to report that Justice Neil Gorsuch delivered a unanimous Supreme Court opinion finding that the Eleventh Circuit applied the wrong legal test, sending the case back for further review. This case is about upholding laws enacted by Congress and ensuring that individuals harmed by the government receive the relief they are rightfully entitled to—free from misguided judicial rulings.

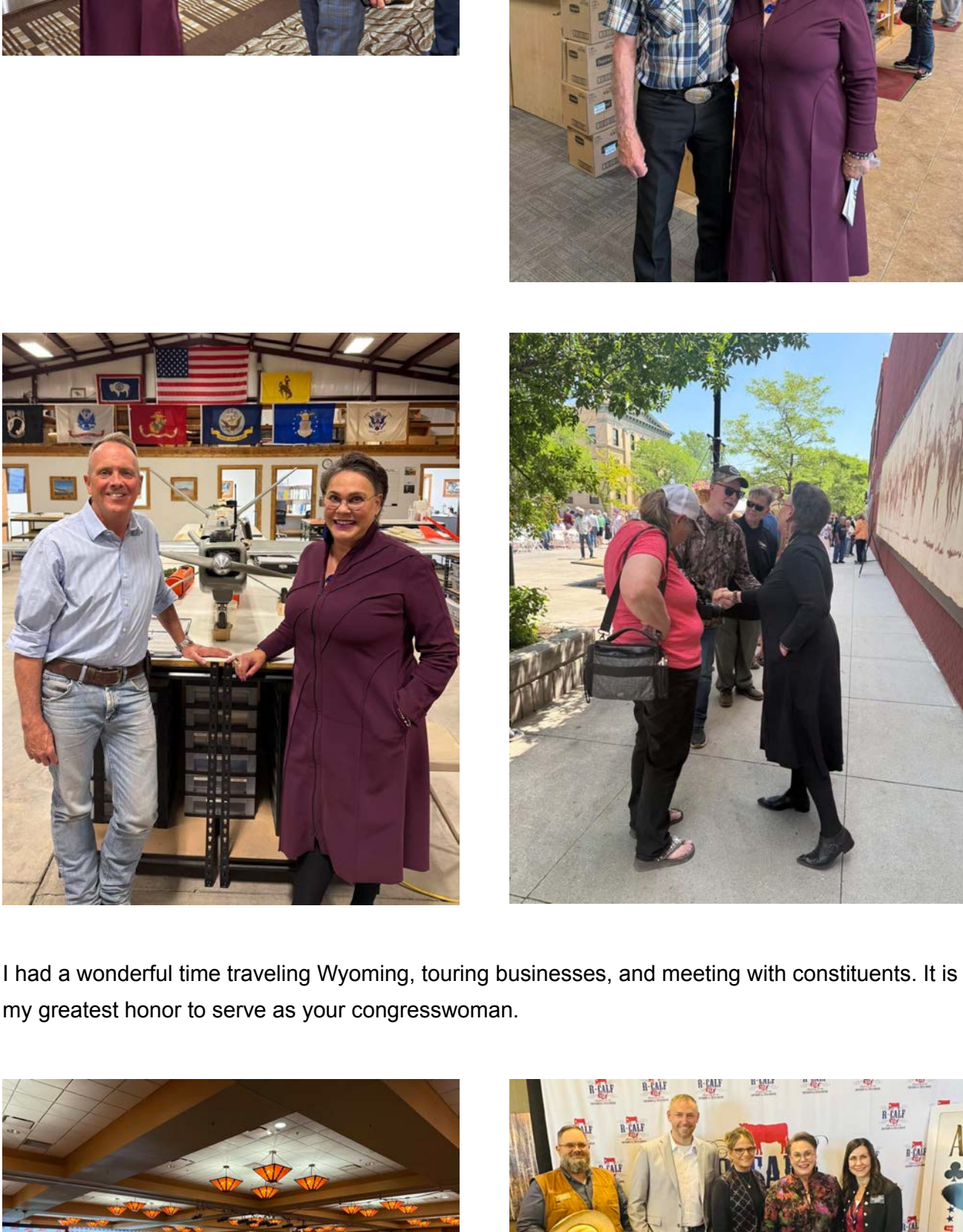
Public Comment Alert!

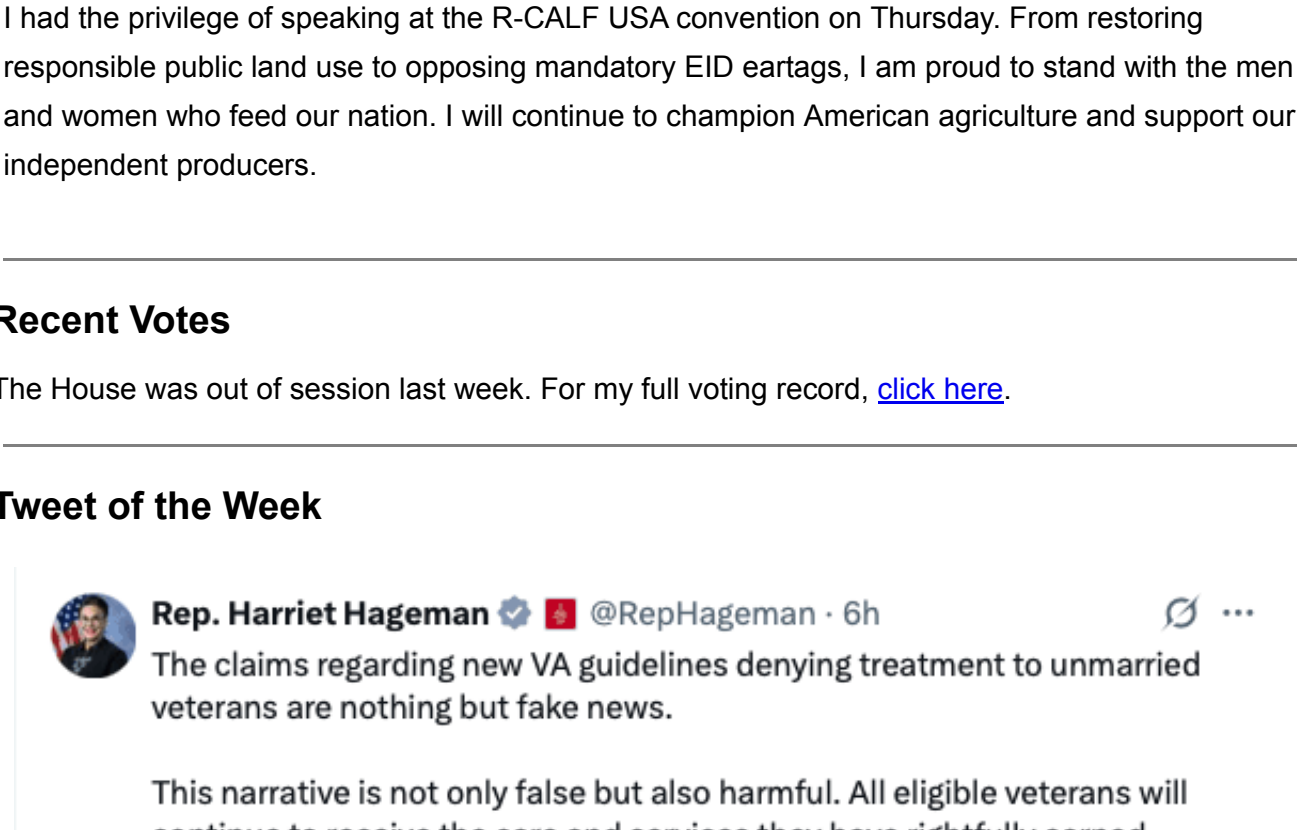
Great Opportunity for Veterans!

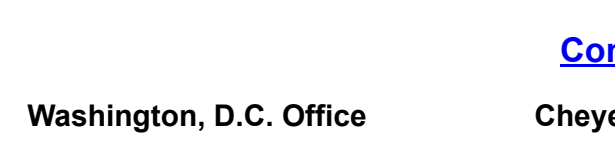

Hageman Says Vast Swaths Of Wyoming Public Lands Won't Be Sold

Despite widespread misinformation online, a Senate committee's proposal to sell public lands across eleven Western states does not target millions of protected acres in Wyoming. Instead, it would make small, select parcels of BLM and USFS lands eligible for sale to help address housing shortages. Importantly, the proposal exempts federally protected lands, including national parks.
