After seven long but productive weeks of votes and hearings in Washington, I will be returning to Wyoming! It will be so good to be home.

Over the next two weeks I will be meeting with folks from across the state and will fulfill my promise to hold an official town hall in every county at least once each year. Thank you to everyone who has reached out to my offices to voice your support of the job I have been doing; it is such a privilege to represent Wyoming, to bring some sanity back to Congress, and to make sure that your voices are heard.

Interviewing John Durham

John Durham dedicated his life to public service, spending decades in the Department of Justice. He was tapped by Attorney General Barr in 2020 to investigate the "Russia, Russia, Russia" hoax, and report his findings. He finally issued his report last month, laying out what he found related to the "Crossfire Hurricane" investigation, describing who instigated it, how it was carried out, the corruption and lies that formed its foundation, and how our flagship law enforcement agencies have been compromised. In short, Mr. Durham has revealed the corruption and politicization within the very institution to which he gave his career.

Mr. Durham's Report is important for many reasons, including by exposing the unassailable fact that there was never any collusion of any kind between President Trump and Russia, and all claims to the contrary were created to destroy his campaign and taint his presidency. Mr. Durham has also confirmed that the players involved in this saga --- from Hilary Clinton and her campaign apparatus, to the DOJ and the FBI, and even Presidents Obama and Biden – knew that Mr. Trump had never worked with Russia in the lead-up to the 2016 election, and that all of the claims to the contrary were nothing but a political dirty trick based upon opposition research that wasn't worth the paper it was written on. In fact, Mr. Durham has reported that not one of the allegations included in the "Steele dossier" have ever been verified.

The legacy of "Crossfire Hurricane" and everyone involved in trying to frame President Trump is the destruction of some of the most important attributes of this country. In their efforts to destroy a presidential candidate and later a President, these purveyors of corruption have destroyed American's faith in our institutions and furthered the erosion of our justice system. During his nearly 6 hour testimony, Mr. Durham exposed the corruption and cover-ups committed by the Obama Administration, Congressional Democrats, and unelected bureaucrats. I asked Mr. Durham just one question- how long will our country be able to survive with a two-tiered justice system that seeks to persecute and prosecute people based on their political beliefs? His response was sobering: "I don't think things can go much further... the nation can't stand under those circumstances."



Censuring Adam Schiff

One outcome of the Durham report may not come as a surprise: Adam Schiff repeatedly lied and intentionally deceived the American people about his claims of "Russia, Russia, Russia" collusion. In his petty and dishonest crusade against President Trump, Schiff forced our government to waste millions of taxpayer dollars in a pointless and fruitless investigation as the Hillary Clinton campaign, and later the FBI and DOJ, sought to prevent President Trump from being elected and, once he was, from being able to govern.

This week my Republican colleagues and I formally censured Representative Schiff in the House of Representatives. This resolution begins an official Ethics Committee investigation into the actions of Mr. Schiff. As importantly, this formal and very public rebuke is permanently written in to the history of the House of Representatives as he becomes only the 25th member censured by the People's House.

Here are some highlights of bills I'm cosponsoring:

- H. Res. 521, Censuring Adam Schiff, Representative of the 30th Congressional District of California.
- H.R. 3072, the *Promoting Free and Fair Elections Act*, which prohibits the use of government funds, property, or websites by NGOs for voter registration or mobilization activities.
- H.R. 3115, the *Public Service Reform Act*, which will reclassify all federal employees in the executive branch as at-will employees.
- H.R. 3175, the *Regulation Reduction Act of 2023*, which requires agencies to repeal at least 2 related regulations for every new rule issued, among other requirements.
- H.R. 3176, the *Veterans Health Care Freedom Act,* which directs the Secretary of Veterans Affairs to conduct a pilot program to improve veteran medical care access within the VA and other community health care providers.
- H.R. 3185, the *DCA Act of 2023,* which increases the amount of flights authorized to and from Ronald Reagan Washington National Airport.
