
Hello Laura,

The House of Representatives returned to session last week, with a full schedule of votes, committee hearings, and constituent meetings. I recently introduced legislation to prevent the city of Washington, D.C. from codifying *Chevron* deference and co-led two additional bills—one to improve the home buying process for our nation's veterans, and another to designate June as "Family Month" in recognition of the foundational role families play in our society.

## The One Big Beautiful Bill Act—What's in It?

I have received numerous inquiries about what is and is not in the One Big Beautiful Bill Act (OBBBA), for which I recently voted. To help clarify, please watch the below video, which addresses the most frequently asked topics.



## My Bill Prohibits D.C. from Codifying *Chevron* Deference

As your representative, one of my top priorities is advancing meaningful regulatory reform. Last year, the U.S. Supreme Court rightly overturned the *Chevron* deference doctrine—a decision that restored judicial independence and curtailed the unchecked power of the administrative state. *Chevron* had long required courts to defer to federal agencies' interpretations of ambiguous statutes, weakening the judiciary's constitutional role and placing a thumb on the scales of justice in favor of the government and against individual litigants.

Despite this important ruling, the Washington, D.C. City Council recently enacted a temporary measure mandating judicial deference to the mayor's and government agencies' interpretations of the law. This policy is scheduled to remain in effect until October 18th, while the Council simultaneously pushes for permanent legislation to enshrine this deference to the unaccountable.

Because the Constitution grants Congress oversight authority over the District of Columbia, I introduced legislation to block these efforts. My bill repeals the temporary law and prevents D.C. courts from being compelled to defer to agency or mayoral interpretations of statutes. This is about ensuring that unelected bureaucrats are not empowered to interpret and enforce the law without proper judicial oversight—safeguarding the rule of law and the separation of powers.

## Improving the Home Buying Process for Veterans

I joined Rep. Brittany Pettersen (D-CO) and a bipartisan coalition of House and Senate colleagues in introducing the Veterans Affairs Loan Informed Disclosure (VALID) Act of 2025. Today, only 10% to 15% of eligible veterans utilize VA home loans, despite the significant savings these programs can offer. The VALID Act requires that veterans receive clear, side-by-side comparisons of VA, Federal Housing Administration, and conventional loan options during the home buying process. This will help ensure veterans are empowered to make informed financial decisions and fully access the benefits they've earned.

With more than 40,000 veterans living in Wyoming, we are reminded daily that our freedoms come at a cost—paid by the selfless service and sacrifices of these brave men and women. Ensuring our veterans receive the care and benefits they deserve is a fundamental obligation. The VALID Act helps fulfill that duty by making sure veterans are fully informed about the advantageous home loan programs available to them as they plan for the future.



## Proclaiming June as Family Month





## Recent Photos
