Thank you, Greater Cheyenne Chamber of Commerce for inviting me to address your members yesterday! We had a PACKED room to hear updates on how I'm working to serve Wyoming in Congress. I look forward to my next chance to visit with you.



New Week, New Bills.

The House of Representatives was back in session with a packed agenda. I introduced two new bills this week - H.R. 1245 and H.R. 1246.

Recent years have seen rising encounters between people and "endangered" grizzly bears, and increasingly with deadly results. Much of this is due to the significant increase in the grizzly bear population in the Greater Yellowstone and Northern Continental Divide ecosystems; yet even though grizzly numbers are now more than double their recovery goal, administration officials have routinely failed to remove them from the list of endangered species. My bill, [H.R. 1245](#), seeks to celebrate the Endangered Species Act in recovering this beautiful and important animal to sustainable levels while managing the threat that an increasingly large population poses to people and livestock.

I also introduced [H.R. 1246](#), which will provide Native American tribes the flexibility to enter their lands into leases of up to 99 years, remove the growth-stifling approval process and length limitations imposed by the Long-Term Leasing Act. Extending tribal land leasing will unlock new economic opportunities for tribes across the U.S. and increase their ability to chart a prosperous future. 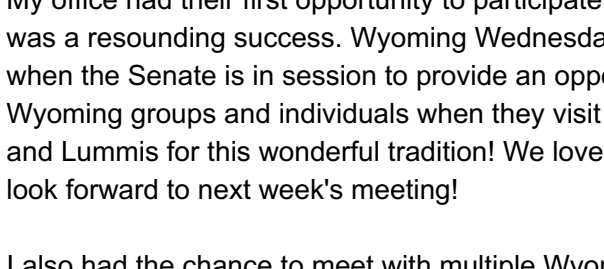
- Voted **YES** on [H. Res. 132](#), offering condolences to the families of those killed by the recent earthquakes in Turkey and Syria, encouraging organizations to continue disaster response efforts, and condemning the oppressive Assad regime for exploiting victims of the disaster
- Voted **YES** to [H.R. 538](#), the Informing Consumers about Smart Devices Act
- Voted **YES** on [H.J. Res. 30](#), which nullifies a Department of Labor rule promoting Environmental, Social, and Governance investment funds
- Voted **YES** on [H.R. 347](#), which requires the executive branch to provide an inflation estimate for each executive order with an expected impact of \$1 billion dollars or more

Here are some highlights of [new bills I'm cosponsoring](#):

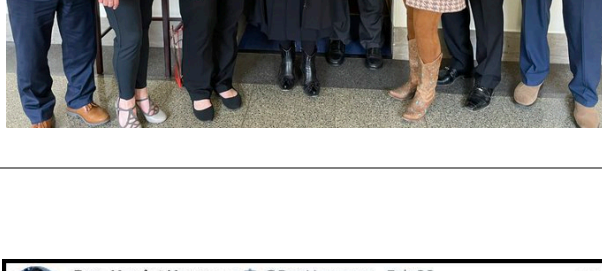
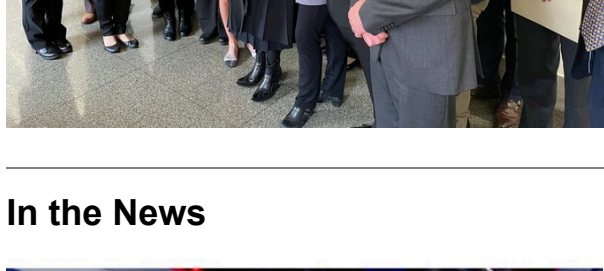
- **H.R. 1271**, which forces the government to stop creating a database of gun owners and destroy any existing records.
- **H.R. 1282**, which would finally provide combat disabled Veterans access to the full military benefits they were promised, in addition to the disability compensation they deserve.
- **H.R. 1228**, which prevents the U.S. military from promoting Critical Race Theory concepts and other anti-American and racist theories, including at service academies.

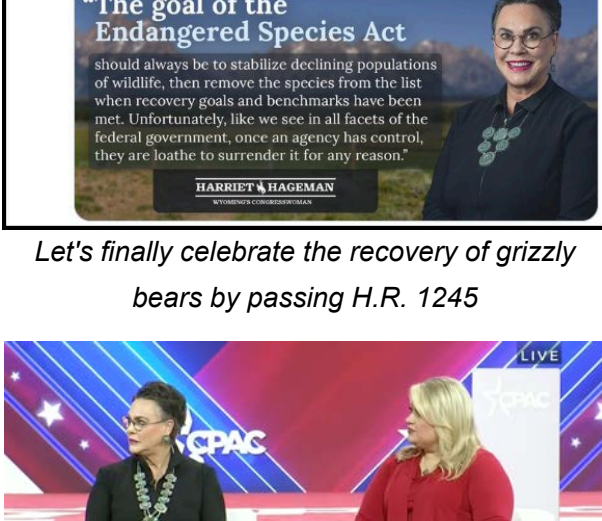
I also had the chance to meet with multiple Wyoming groups visiting DC this week; we may have to look at getting some larger meeting spaces soon to fit everyone!



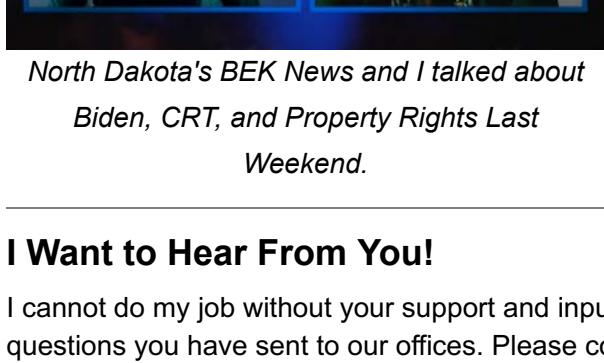

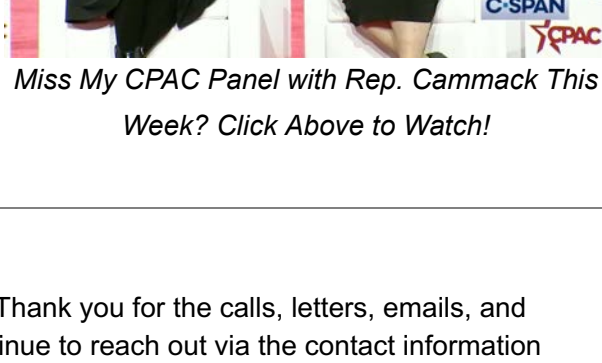
