Hello Laura,

Last week was an exciting time in Washington, D.C.! I was honored to attend President Trump's joint address to Congress in which he touted his accomplishments and outlined his plans to Make America Great Again. I look forward to assisting him implement his agenda in my role as your representative. I also enjoyed meeting with dozens of constituents who were in town for meetings, tours, and more.

On the legislative side, I participated in hearings in both the Judiciary and Natural Resources Committees. I also introduced legislation to protect parents' rights and sent a letter to the U.S. Postal Service (USPS) opposing its Delivering for America plan. Keep reading this weekly update to learn about these important issues.

## Working to Reform the Endangered Species Act

I have participated in numerous Natural Resources Committee hearings over the last few weeks, focusing on the Endangered Species Act (ESA). One of the primary issues before us is the fact that federal bureaucrats and environmental activists have misinterpreted the ESA in order to keep species such as gray wolves and grizzly bears listed, despite the fact that they have been fully recovered—for literally decades. I am pleased to co-sponsor Chairman Bruce Westerman's (R-AK) legislation, the ESA Amendments Act of 2025, which is aimed at addressing this specific issue, along with many others.

This bill reforms the ESA by prioritizing conservation resources, streamlining the permitting process, and incentivizing state and private landowner involvement. It codifies scientific data standards, limits critical habitat designations, and sets clear recovery goals for species. This will enhance transparency in decision-making and ensure that federal agencies cannot impose unnecessary mitigation requirements. By clarifying definitions and streamlining processes, we can better manage wildlife populations while respecting the rights of states, Tribes, and private landowners.

## My Bill Will Protect Parental Rights

On Wednesday, I joined Senator Jim Banks (R-IN) in introducing [H.R. 1866](#), the Guaranteeing Unalienable and Anatomical Rights for Dependents (GUARD) Act. This legislation disqualifies states from receiving federal funding under the Child Abuse Prevention and Treatment Act if they discriminate against parents or guardians who refuse to impose harmful, institution-driven gender confusion on their children. Specifically, adverse action or other forms of discrimination taken against parents who oppose medical, surgical, pharmacological, or psychological treatment, clothing, name or pronoun use, or other social changes related to the affirmation of a child's "gender identity" different from their biological sex would all constitute ineligibility for federal funding.

As the chair of the Anti-Woke Caucus and a staunch supporter of parental rights, particularly when it comes to the indoctrination of young kids, I refuse to stand idly by while parents are ignored and admonished for protecting their children. This bill defends parents' rights and keeps child protective services focused on its true mission.

## Urging the USPS to Reconsider its DFA Plan

On Friday, I was joined by Senators Barrasso and Lummis in sending a [letter](#) to the USPS highlighting our continued concerns with its "Delivering for America" (DFA) plan, encouraging the USPS to heed the warnings of the Postal Regulatory Commission's (PRC) advisory opinion which found significant problems with the plan, and requesting additional information about its recent announcement for Cheyenne and Casper facilities and services.

Specifically, the PRC concluded that the DFA plan "depends on defective modeling and does not appear to be ready for implementation," "relies on overly optimistic and unsubstantiated financial projections for cost savings that are not likely to improve the financial health of the Postal Service," and, most disturbingly, "has significant negative impacts on rural communities throughout the U.S." The analysis further found that the USPS's flawed volume-based approach to measuring service degradation as opposed to more representative alternatives obscures the true cost these changes will have on rural communities. Measuring the impacts of these changes on Single-Piece First Class Mail, approximately 49.5% of ZIP Codes will receive degraded service.

Should these changes go into effect, rural mail in Wyoming and across the country will be severely impacted. As your representative, I will continue my fight to ensure Wyoming's voice is heard and your mail service is never sacrificed.
