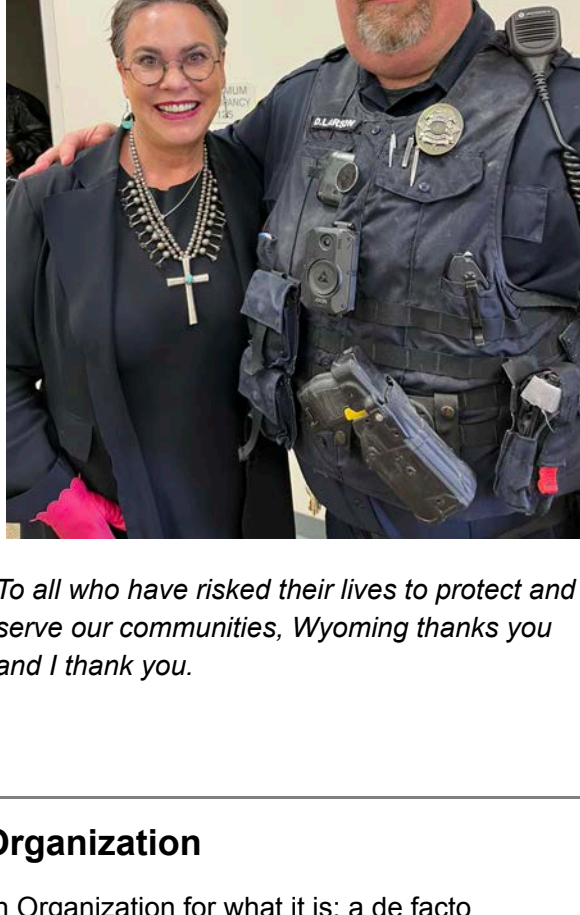

## Wyoming Backs the Blue

In honor of National Police Week, the House of Representatives passed multiple law enforcement-related bills this week in an effort to honor the sacrifice of our men and women in uniform and to provide additional protection for them.

On Tuesday, the members of the House overwhelmingly voiced our support in recognition of the vital job our local law enforcement professionals perform, and the need to ensure they have the resources and training required to keep themselves and the public safe.

We continued this theme on Wednesday, passing bipartisan bills to allow federal law officers to purchase the retired service weapons they have carried in the line of duty, and to classify the assault of a law enforcement officer by a non-citizen as a deportable offense. We concluded this week by passing H.Con.Res 40, which applauds the devotion of our local law enforcement officers to their communities and condemns all efforts to defund, dismantle, or abolish the police.

## It's Time to Defund the World Health Organization

The past three years have exposed the World Health Organization for what it is: a de facto mouthpiece for Chinese Communist Party propaganda – a mouthpiece that receives significant funds from the American taxpayers to which it has caused great harm. The WHO is corrupt and we should not continue to fund it. This week, I spoke out against the WHO, joining over a dozen other members of Congress to condemn what it has done.

International agreements do not trump the United States Constitution, and President Biden cannot force Americans to comply with regulations and laws that are not passed by Congress. American taxpayer dollars should not be sent to an organization that props up the CCP's lies and that causes world-wide damage and suffering.

The above title says it all: it's time to defund the WHO.

## Extending the Comment Period on BLM's "Conservation and Landscape Health" Rule

Once again, the Biden Administration is attempting to impose overbearing, unnecessary, unlawful, and destructive policies in relation to federal land management. The Bureau of Land Management (BLM) recently published a proposed rule that would promote "conservation" as a land use designation on par with the existing statutorily-mandated multiple uses.

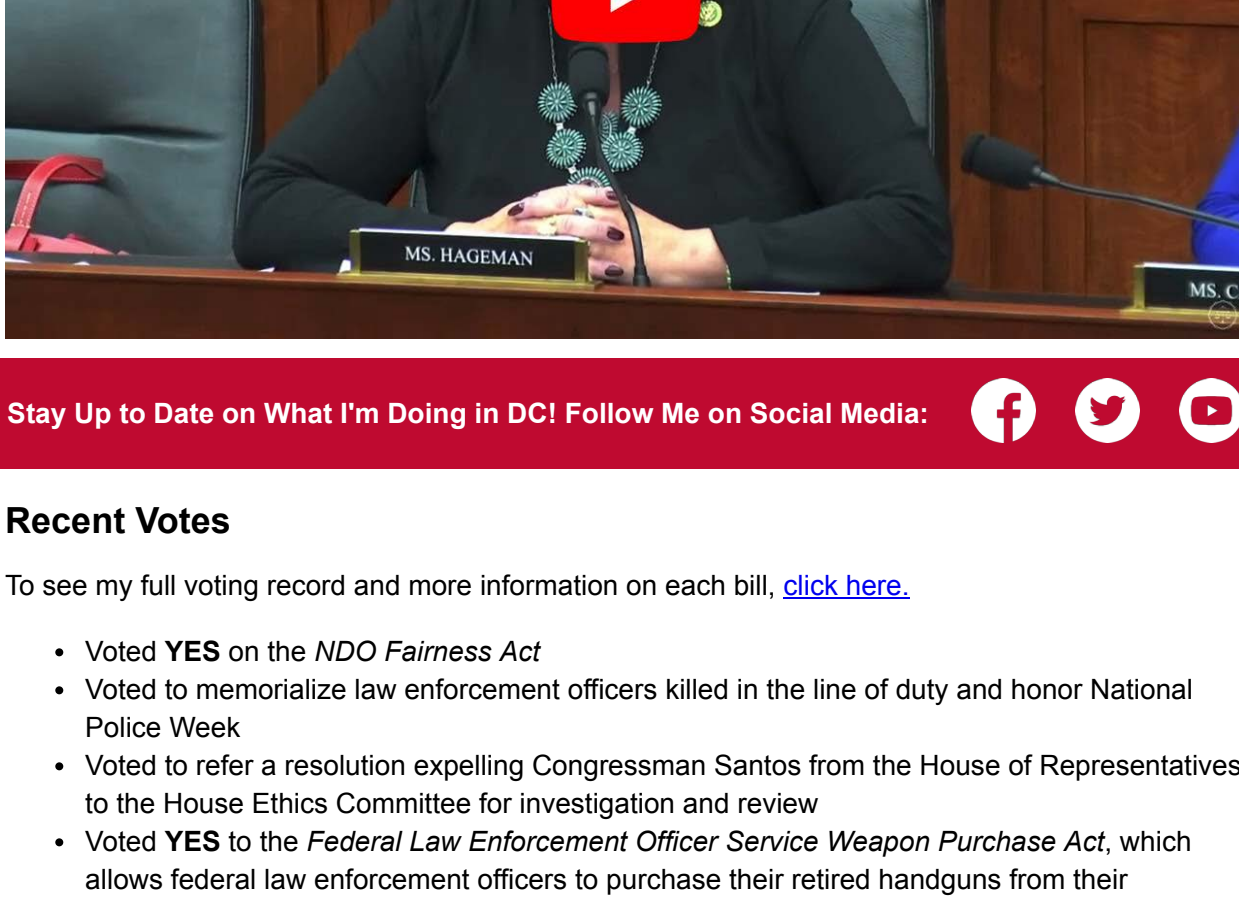
This new designation will have far-reaching implications and fundamentally change the way the BLM carries out its multiple-use-and-sustained-yield mandate. The fact that BLM currently plans to hold just 3 in-person listening meetings regarding the rule tells you everything you need to know. The Biden administration is seeking to fundamentally change the authority and mission of the BLM, while also excluding and ignoring those who will be most impacted, meaning those of us who live in the interior west, with 99% of BLM land being contained across the 12 Western states.

Lawmakers on both sides of the aisle have voiced concern about this proposed rule, with Wyoming being especially negatively impacted if it is implemented. For that reason, I joined many of my colleagues and asked Interior Secretary Haaland to extend the comment period by 75 days and provide additional listening – and discussion -- sessions to ensure Wyoming's well-founded concerns on this rule are heard. I will also continue to push the BLM to produce legitimate and supportable data on how they intend to "value" such conservation leases to ensure that the BLM carries out its statutory obligation to maximize revenue from these lands.

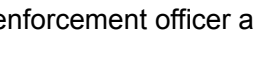
## The FBI's Vindictive Attacks on Whistleblowers

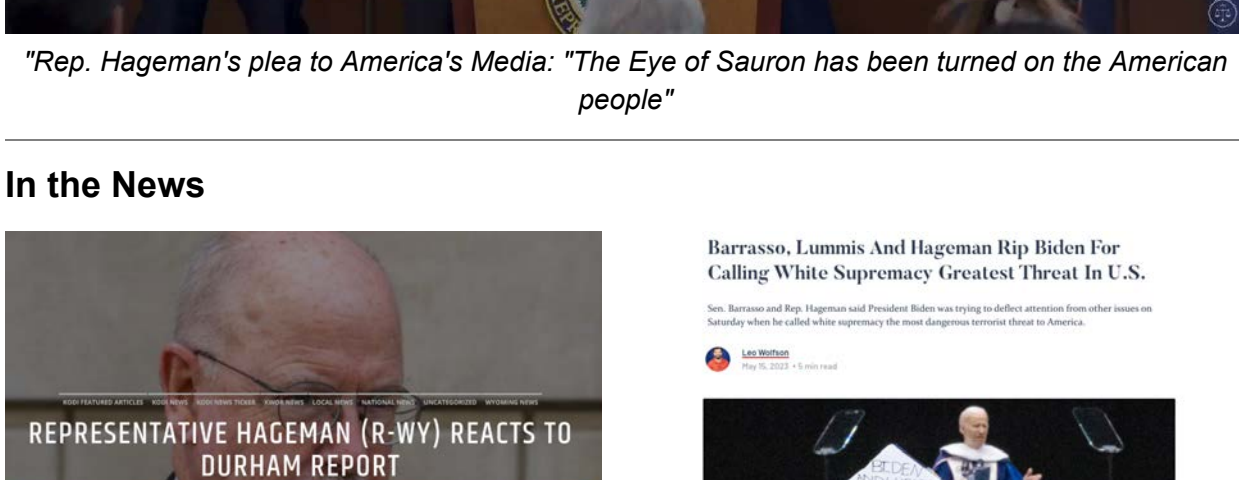

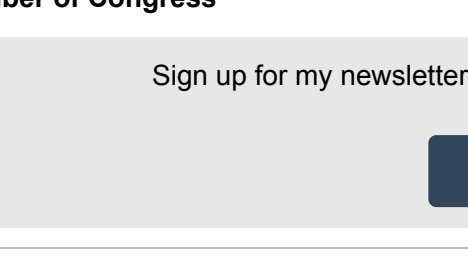

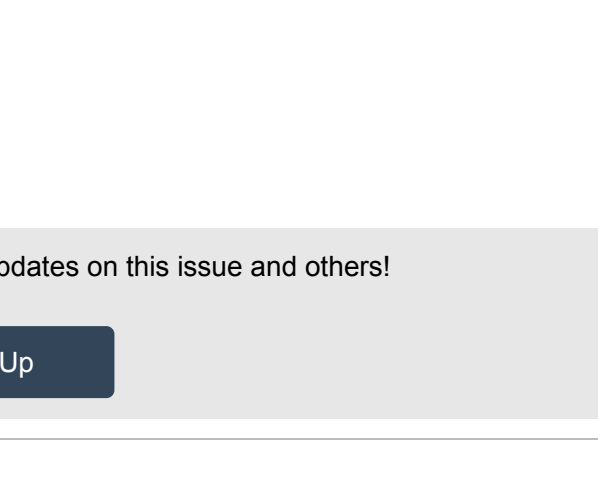
